PRODUCTION PROCEDURES	<p>Antiserum was cross adsorbed using bovine, chicken, horse, human, mouse, rabbit, rat & sheep immunosorbents to remove cross reactive antibodies. The antibody to syrian hamster IgG was isolated by affinity chromatography using antigen coupled to agarose beads and conjugated to DyLight® 594.</p> <p>Antibody concentration was determined by extinction coefficient: absorbance at 280 nm of 1.4 equals 1.0 mg of IgG.</p> <p>By immunoelectrophoresis and ELISA this antibody reacts specifically with syrian hamster IgG and with light chains common to other syrian hamster immunoglobulins. No antibody was detected against non-immunoglobulin serum proteins. Less than 1% cross reactivity to bovine, chicken, horse, human, mouse, rabbit, rat & sheep IgG was detected. This antibody may cross react with IgG from other species.</p>
