	By immunoelectrophoresis and ELISA this antibody reacts specifically with mouse IgM. Cross reactivity with IgA and IgG is negligible. No antibody was detected against non-immunoglobulin serum proteins. Less than 1% cross reactivity to human and rat IgM was detected. This antibody may cross react with IgG from other species.
